The franchisee will operate a retail outlet ("Flower Tent Business") that offers quality fresh flowers, plants, and related items for sale to the general public at a fair price.

The total investment necessary to begin operation of a Flower Tent franchise ranges from \$21,050 to \$92,200. This includes \$5,000 to 15,000 that must be paid to Flower Tent USA, Inc. If you enter into a Development Agreement to develop multiple Flower Tent Businesses, you also will pay to us a Development Fee, which is credited against your Initial Franchise Fee, in the amount of \$7,500 for your first business, \$5,000 for your second business and \$2,500 for any subsequent business(es) that you commit to develop.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

EXCEPT FOR CONTROVERSIES OR DISPUTES WHERE PROVISIONAL OR INJUNCTIVE RELIEF IS SOUGHT, THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN THE COMMONWEALTH OF PENNSYLVANIA. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN PENNSYLVANIA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT PENNSYLVANIA LAW GOVERNS THE AGREEMENT. THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
