Flowers Baking Co. of Norfolk, LLC ("Flowers") manufactures and/or distributes various bakery products, most of which are then distributed to retail stores and other customers (including military and institutional accounts) through a network of independent distributor franchisees. The total investment necessary to begin operation of a Flowers distributorship ranges from \$35,930 to \$169,100. This includes \$30,000 to \$100,000 that must be paid to Flowers.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Do not rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind. 2. SHOULD YOU ELECT OPTIONAL FINANCING FOR THE TERRITORY FEE AVAILABLE FROM FLOWERS FINANCE, LLC, YOU WILL BE REQUIRED TO SIGN A SECURED PROMISSORY NOTE (“NOTE”). THE NOTE STATES THAT GEORGIA LAW GOVERNS THE NOTE, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS THE LAWS OF THE STATE OF YOUR RESIDENCE IF YOU ARE NOT A RESIDENT OF THE STATE OF GEORGIA.
