Floyd's 99 Franchising, LLC is offering franchises for the operation of retail hair care businesses operated under the service mark "FLOYD'S 99" and featuring haircutting, coloring and barbering provided to clients in a modern atmosphere by a staff of well-trained, licensed professionals

The total estimated investment necessary to begin operation of a FLOYD'S 99 business ranges from \$238,000 to \$457,000. These amounts include between \$38,150 and \$38,500 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

DEPENDING ON THE LENGTH OF THE REMAINING TERM OF THE FRANCHISE AGREEMENT, WE ESTIMATE THE AMOUNT OF LOST FUTURE ROYALTIES COULD BE AS HIGH AS \$408,000. THE PRECEDING ESTIMATE IS NOT INTENDED AND SHOULD NOT BE CONSTRUED AS A FINANCIAL PERFORMANCE REPRESENTATION.**
- 4 THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.**

We reserve the right to use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source is our agent and represents us, not you. We pay this person a fee for selling our franchise or referring you to us.
