You will operate a shop offering a shaved ice-based dessert served with sweet toppings, such as chopped fruit, condensed milk, chocolate syrup, puddings, jellies, mochi, boba, granola, and graham crackers, under the name FLUFF ICE.

The total investment necessary to begin operation of a FLUFF ICE® franchised business ranges from \$169,500 to \$533,400. This includes \$37,500 to \$47,000 that must be paid to the Franchisor or its affiliate(s). If you are acquiring development rights under our multi-unit development program, then you will sign our development agreement and pay us an initial development fee calculated as the sum of \$35,000 for the first Shop, plus \$25,000 for each additional Shop to be developed under the development agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
