We offer a franchise for a business using the "FOOT SOLUTIONS" and "FOOT SOLUTIONS HQ" service marks and trade names offering foot care services, including computer foot scanning, custom, accommodative insoles, orthotics, arch supports and a line of specialty shoes and foot care products. Although we are not a medical type facility, some of our stores do work with Medicare and the medical community. If this is an area of our business model you are interested in, we suggest you also review the current requirements in your state.

The total investment necessary to begin operation of a FOOT SOLUTIONS franchise for a Storefront location is approximately \$222,000, while the investment for a Mobile Unit concept is approximately \$85,000. (See Item 7.) For the Storefront concept, this amount includes approximately \$129,000, which must be paid to us and our affiliates for the \$32,500 Initial Franchise Fee, equipment, signage, trade fixtures, inventory and a point of sale system. (See Item 5.) For the Mobile Unit concept, this amount includes approximately \$50,000 for the \$29,500 Initial Franchise Fee, equipment, van wrap, foot scanner, and inventory.

This Disclosure Document summarizes certain provisions of the Franchise Agreements and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your Disclosure Document in another format that is more convenient for you. The terms of your contract will govern your franchise relationship. Do not rely on the Disclosure Document alone to understand your contract. Read your entire contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind.
