The franchise offered is a restaurant concept featuring soft serve confections, soft drinks, hamburgers, hot sandwiches and other food items.

The total investment necessary to begin operation of a Fosters Freeze Standard Store franchise is between \$443,000 and \$448,000. This includes \$25,000 that must be paid to the franchisor. The total investment necessary to begin operation of a Fosters Freeze C-Store franchise is between \$209,500 and \$276,500. This includes \$5,000 that must be paid to the franchisor. The total investment necessary to begin operation of a Fosters Freeze Fountain-Only franchise is between \$57,000 and \$109,000. This includes \$5,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
