The sub-franchisee will operate an adult dance studio offering dance instruction and related services operating under the name “Fred Astaire Franchised Dance Studio®.” The estimated total investment necessary to begin operation of a sub-franchised business is from \$87,500 to \$191,000. This includes an initial sub-franchise fee of \$25,000 that must be paid to the area franchisor.

This Disclosure Document summarizes certain provisions of your Sub-Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment, to the area franchisor or an affiliate in connection with the proposed sub-franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

Buying a franchise, including a sub-franchise, is a complex investment. The information in this Disclosure Document can help you make up your mind.
