

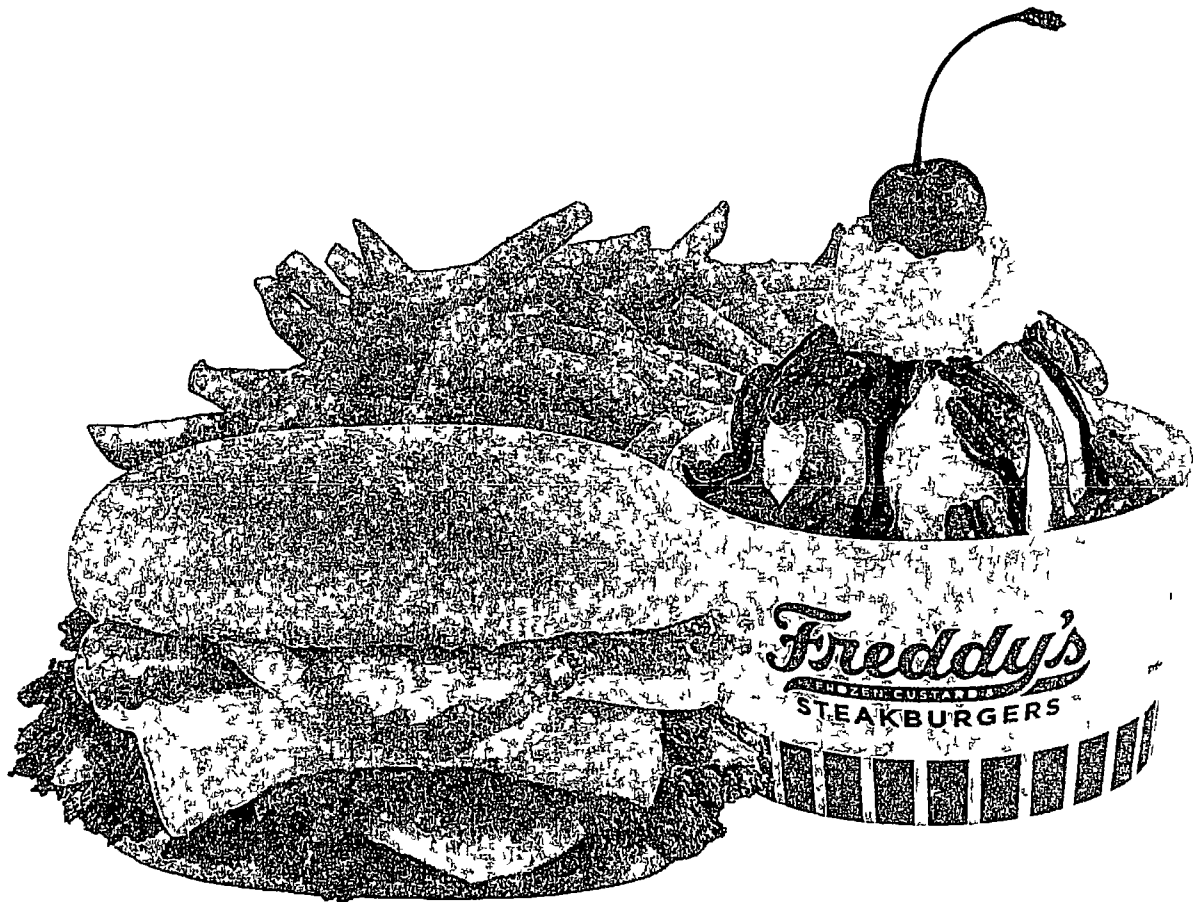

As a franchisee, you will operate a restaurant featuring the retail sale of steakburgers, hot dogs, and frozen custard to the general public

The total investment necessary to begin operation of a FREDDY'S FROZEN CUSTARD & STEAKBURGERS® franchise ranges from \$596,205.34 to \$1,142,337. This includes \$25,000 that must be paid to the franchisor. The initial development fee will generally be the sum of \$5,000 times the number of Restaurants to be established, which will be payable upon signing of the Development Agreement.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don't rely on the Disclosure Document alone to understand your contract. Read all of your contract carefully. Show your contract and this Disclosure Document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this Disclosure Document can help you make up your mind. More information on franchising, such as "*A Consumer's Guide to Buying a Franchise*," which can help you understand how to use this Disclosure Document, is available from the Federal Trade Commission.
