The franchisor is offering a franchise license for a business that performs residential, dormitory and office cleaning services. The franchise will be referred to as “**freedommaid**®” throughout this document.

The total investment necessary to begin operation of a **freedommaid**® franchise is between \$49,485 and \$103,140. This includes \$24,500 to \$52,500 that must be paid to the Franchisor and its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
