The franchise offered is to operate a French Fry Heaven business that features and offers for sale classic Belgian-style russet potato french fries and sweet potato french fries with a variety of distinctive dustings, toppings, spices, and proprietary and non-proprietary sauces

The total investment necessary to begin operation of a French Fry Heaven franchise is \$113,600 to \$199,900. This includes \$27,000 to \$29,000 that must be paid to us or our affiliates. If you enter into an area development agreement for the right to develop multiple French Fry Heaven businesses, you will be required to pay us a development fee equal to 50% of the initial franchise fees payable for those businesses.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
