We offer franchises for the operation of "Froots" stores offering freshly prepared smoothies, shakes, juices, coffee, salads, soups, wraps and Panini's which may be operated from a retail store located in a strip mall, shopping center or other similar location.

The total investment necessary to begin operation of a Froots Franchising Companies, Inc. storefront franchised business is from \$149,150 to \$321,750. The total investment necessary to begin operation of a Froots Franchising Companies, Inc. franchised 10x10 Kiosk franchise business is \$92,600 to \$113,450. The total investment necessary to begin operation of a Froots Franchising Companies, Inc. franchised 10x20 Kiosk franchise business is \$127,500 to \$157,600. This includes \$25,000 (for the first franchise) that must be paid to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. - 2. THE FRANCHISE AGREEMENT STATES THAT FLORIDA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
