Frosted Robin Franchising, LLC, sells franchises for upscale cafes that offer gourmet fresh-baked cupcakes, teas, coffees, and other specialty products together with clothing, accessories, novelty items and promotional merchandise and related products and services under the trademark "Frosted Robin." We offer 2 franchise programs.

<u>Single Cafe Program</u>. Under this program you will sign a Franchise Agreement to operate one Frosted Robin Cafe with an on-site baking facility The total amount necessary to begin operation of a Frosted Robin Cafe ranges from approximately \$196,100 to \$428,000. This amount includes a \$30,000 Franchise Fee that must be paid to us.

Multi-Unit Program. Under this program you will sign a Multi-Unit Agreement under which we will assign you a defined area within which you must develop and operate a specified number of Frosted Robin Cafes within a specified period of time. For each Cafe you agree to open under a Multi-Unit Agreement you must pay a Multi-Unit Fee of \$10,000 \$10,000 of this Multi-Unit Fee will be applied against the Franchise Fee for each Cafe you open under the Multi-Unit Agreement. At our discretion and subject to our approval, you may opt to have "Hub" Cafes with on-site kitchens which prepare and supply Frosted Robin baked goods for sale at your "Satellite" Cafes which do not have on-site baking facilities. The total amount necessary to begin operation of the first Cafe under the Multi-Unit Program is identical to the amount under the Single Cafe Program (ranging from approximately \$196,100 to \$428,000), however you may have reduced costs for subsequent Cafes arising from increased purchasing power and overlapping expenses. Additionally, Satellite Cafes may have reduced costs because they will not require baking equipment and supplies, baking employees, and utilities costs relating to baking, and they may require less space leading to reduced rent. However, you will be required to acquire a vehicle to transport baked goods to your Satellite Cafes.
