We are **G & S FRUGALS, INC.**, a Washington Corporation. As a franchisee, you will operate a business offering and selling a limited menu of hamburgers, sandwiches, french fries, milkshakes, soft drinks and other complementary items, prepared to order operating under our trademarks and service marks ("Marks") and following our proprietary systems ("System").

The approximate total investment to begin operation of a Frugals® franchise is from \$831,000 to 1,126,000. This includes \$25,000.00 that must be paid to the franchisor or affiliate. This estimate applies separately to each Restaurant to be developed under an Area Development Agreement.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. you must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
