The Company offers fivefour franchise packages for the distribution and sale of **FRUITFULL**<sup>®</sup> frozen fruit bars, confection bars, confection items, frozen desserts and other **H** & **H** Products through dedicated freezers placed in retail outlets, through a retailer's own freezers and via freezers mounted in carts <u>A Retail Franchise involves purchase of at least one freezer, one cart and one pallet of frozen H & H Products</u>. A Standard Frozen Wholesale Franchise or Standard Premium All Products Wholesale Franchise involves purchase of at least 10 freezers and 2 pallets of frozen H & H Products. A Grand Frozen Wholesale Franchise or Grand Premium All Products Wholesale Franchise involves purchase of at least 20 pallets of frozen H & H Products A Grand Frozen Wholesale Franchise or Grand Premium All Products A Super Grand Wholesale Franchise involves purchase of at least 30 freezers and 3 pallets of frozen H & H Products A Premium Wholesale Franchise involves purchase of at least 50 freezers and 3 pallets of frozen H & H Products A Premium Wholesale Franchise involves purchase of at least 50 freezers and 3 pallets of frozen H & H Products A Premium Wholesale Franchise involves purchase of at least 50 freezers and 3 pallets of frozen H & H Products.
