We offer *Frullati Cafe & Bakery*[™] franchises. As a franchisee, you will operate a restaurant called *Frullati Cafe & Bakery*, specializing in freshly prepared Paninis, sandwiches, salads, soups, fresh baked goods, blended fruit drinks, and proprietary nutritional products and supplements.

The total investment necessary to begin operation of a *Frullati Cafe & Bakery* franchise ranges from \$140,410 to \$514,750 for a traditional franchise unit constructed as a free-standing restaurant; from \$140,410 to \$444,750 for a traditional franchise unit located within a shopping mall, strip center, or similar venue; and \$129,010 to \$330,250 for a non-traditional franchise unit. This includes \$17,500 to \$114,450 for a traditional location and \$9,100 to \$88,750 for a non-traditional location that must be paid to the franchisor or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully.
