The franchisee will operate a restaurant under the name "Fuddruckers," featuring, in part, large, high quality, upscale hamburgers.

The total investment necessary to begin operation of a Fuddruckers Restaurant ranges from approximately $\frac{1,165,000490,000}{1,560,0001,560,000}$. This figure includes an Initial Franchise Fee ranging from \$35,000 to \$50,000, which must be paid to us. This range does not include the cost of buying or renting the business location or obtaining a liquor license.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
