Fujisan Franchising Corp. will grant you a franchise to operate one FujiSan[®] Asian bar service kiosk (each, a "Kiosk") in a host location, such as a retail grocery outlet, using a distinctive system. The initial franchise fee is \$500 for a Satellite Kiosk and \$3,750 for a Traditional Kiosk and is payable when you sign your franchise agreement. The total investment necessary to begin operation of a FujiSan Kiosk franchised business is \$28,165 to \$74,305 for a Traditional Kiosk and \$3,050 to \$19,550 for a Satellite Kiosk. This includes \$17,840 to \$32,280 for a Traditional Kiosk and \$750 to \$6,050 that must be paid to the franchisor and/or its affiliate.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

You may wish to receive your disclosure document in another format that is more convenient for you. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN CALIFORNIA THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT STATES THAT, WITH SPECIFIC EXCEPTIONS, CALIFORNIA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
3. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
