FULL BODY INDOOR CYCLING

The franchisee will operate an indoor cycling studio at a single location that offers full body workouts by combining cycling routines with upper body strength training. The total investment necessary to begin operation of a Full Psycle franchise ranges from \$274,660 to \$535,000. This includes \$45,000 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
