Black, Rock, BAR & GRILL

The franchise offered is for a full service restaurant operating under the name "Black Rock Bar & Grill". A "Black Rock Bar & Grill" restaurant offers Australia-style rock cooking where certain menu items are cooked on a hot volcanic rock at the customer's table, as well as a diverse menu offering steaks, seafood, pasta, burgers, soup, salads and beverages (including alcoholic beverages). A Black Rock Bar & Grill restaurant offers lunch and dinner menus for dine-in and take-out and operates using the franchisor's proprietary recipes, formulae, techniques, trade dress, trademarks and logos.

The total investment necessary to begin operation of a "Black Rock Bar & Grill" franchised business is 1,534,940 to \$2,994,625. This includes between \$50,000 and \$66,500 that must be paid to the franchisor and/or its affiliate.

If you enter into a Multi-Unit Operator Agreement to develop at least three Restaurants, when you sign the Multi-Unit Operator Agreement you will pay a reservation fee equal to \$25,000 for each Restaurant to be developed under the Multi-Unit Operator Agreement. The total investment under a Multi-Unit Operator Agreement will vary depending on the number of Restaurants to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.
