As a franchisee, you will operate a Fun Bus franchise that will provide mobile, on-site fitness and entertainment programs to children on a specially designed bus that travels to schools, day cares, etc. under the trademarks "FUN BUS®" and "FUN BUS FITNESS FUN ON WHEELS®".

The total investment necessary to begin operation of a FUN BUS® franchise ranges from \$85,000 to \$114,500. This includes an initial franchise fee of \$32,500 that must be paid to Fun Bus Franchising Group, LLC.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
