The franchise is for a FYZICAL® physical rehabilitation center (the "**Center**" or "**Business**") that provides patients with physical therapy programs for rehabilitation, balance, medical-based fitness and pain management and other products and services that we authorize from time to time

The total investment necessary to convert an existing business to a FYZICAL® Center ranges from \$82,250 to \$274,500, or \$138,750 to \$399,000 if you are beginning operation of a totally new FYZICAL® Center This includes \$70,000 to \$140,000 that will be paid to the franchisor or affiliate for each Territory that you purchase (\$1 75 per person based on the population in the Territory with a minimum of one Territory consisting of approximately 40,000 people)
