The franchise offered is for the establishment of one or more Games2U franchised businesses (each a "Games2U Business") that provide mobile entertainment using various vehicles, vehicle equipment and game equipment for parties and other events.

The total investment necessary to begin operation of a single Games2U Business ranges from \$125,050 to \$414,100. This includes \$75,750 to \$313,000 that must be paid to us or our affiliates.

If you obtain development rights to develop, open and operate more than one Games2U Business, pursuant to a development agreement, you must also pay a separate development fee equal to 50% of the total initial franchise fees for the second and each additional Games2U Business to be developed under the Development Agreement. The initial franchise fee is \$30,000 for each Games2U Business developed under the Development Agreement. The total investment necessary to operate under a development agreement ranges from \$159,550 to \$481,600.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no government agency has verified the information contained in this document.

RISK FACTORS:

- 1. THE FRANCHISE AGREEMENT AND DEVELOPMENT AGREEMENT REQUIRE THAT ALL DISAGREEMENTS BE LITIGATED IN AUSTIN, TEXAS. OUT OF STATE LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT THAN YOU MIGHT HAVE IN YOUR OWN STATE. IT MAY ALSO COST YOU MORE TO LITIGATE WITH US IN AUSTIN, TEXAS THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT AND DEVELOPMENT AGREEMENT STATE THAT TEXAS LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. LIQUIDATED DAMAGES WILL BE REQUIRED IF THE FRANCHISE AGREEMENT OR DEVELOPMENT AGREEMENT IS TERMINATED WITH CAUSE.
- 4. THE FRANCHISOR COLLECTS ALL FEES THAT YOU TAKE IN AND IN TURN YOU ARE PAID WEEKLY AFTER THE FRANCHISOR TAKES MONIES OWED TO THEM. THIS CAN EFFECT YOUR CASH FLOW.
- 5. YOUR RIGHTS WITH RESPECT TO YOUR TERRITORY ARE DEPENDENT ON PAYING US MINIMUM ROYALTIES ON A CALENDAR MONTH BASIS REGARDLESS OF YOUR ACTUAL REVENUES.
- 6. THE TERRITORY IS NOT EXCLUSIVE. YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM FRANCHISOR OWNED OUTLETS OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS FRANCHISOR CONTROLS.
- 7. YOUR SPOUSE MUST ALSO SIGN A PERSONAL GUARANTEE MAKING YOUR SPOUSE INDIVIDUALLY LIABLE FOR YOUR FINANCIAL OBLIGATIONS UNDER THE AGREEMENT. THE GUARANTEE WILL PLACE YOUR SPOUSE'S MARITAL AND PERSONAL ASSETS AT RISK IF YOUR FRANCHISEE FAILS.

- 8. IF YOU FAIL TO COMPLY WITH THE MINIMUM ROYALTY FEE REQUIREMENT, THEN YOU WILL BE DEEMED TO BE IN DEFAULT AND WE MAY TERMINATE YOUR FRANCHISE AGREEMENT.
- 9. THE FRANCHISOR HAS BEEN IN EXISTENCE FOR A SHORT PERIOD OF TIME, SINCE JUNE 11, 2014. THERFORE, THERE IS ONLY A BRIEF OPERATING HISTORY TO ASSIST YOU IN JUDGING WHETHER OR NOT TO MAKE THIS INVESTMENT.
- 10. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
