The franchise offered is for the operation of customized residential garage floor coating and storage solutions, industrial floor coatings for retail stores and commercial buildings, all using the "Garage Experts" system and standards.

The total investment necessary to begin operation of a Garage Experts franchised business is \$51,532 - \$146,044. This includes \$35,377 that must be paid to the franchisor or affiliate. You may purchase additional contiguous territories available for purchase if approved for \$10,000 per territory.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
