GFC Businesses engage in the sale and installation of floor coatings, primarily on concrete surfaces, for residential and commercial customers (“GFC Business(s)”).

The estimated total investment necessary to begin operations for a GFC Business ranges from \$131,400 to \$213,900. This includes \$83,000 that must be paid to the franchisor or affiliate.
