As a franchisee, you will operate a GARBAGEMAN A Green Company® Franchise Business that offers residential and commercial waste pickup and disposal.

The total investment necessary to begin operation of a GarbageMan franchised business is from \$270,350 - \$414,350.

This includes an initial franchise fee of \$39,500 that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate company in connection with the proposed franchise sale.
