The franchisee will operate a quick serve restaurant and catering and delivery business specializing in Mediterranean cuisine, including hummus, falafel, chicken and beef shwarmas and salads on handmade pita and laffa and soups and desserts under the trademark "Garbanzo Mediterranean Grill".

The total investment necessary to begin operation of a Garbanzo Mediterranean Grill is from \$361,875 to \$962,469. This includes the \$30,000 initial fees that must be paid to the franchisor. If you are granted area development rights under an Area Development Agreement, you will pay a Development Fee of \$5,000 for each proposed Garbanzo Mediterranean Grill restaurant.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

- 5. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
