The franchise offered is for the operation of a Gelsosomo's Pizzeria restaurant. Gelsosomo's Pizzeria franchises are available in carry out or full service restaurants.

- (1) The total investment necessary to begin operation of a Gelsosomo's Pizzeria franchise for carry out is \$238,728, or \$416,935 for a full service location. This includes \$25,000 that must be paid to the franchisor or affiliate.
- (2) This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
- (3) The terms of your contract will govern your franchise relationship. Don't rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to and advisor, like a lawyer or an accountant.
- (4) Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
