The franchise offered is for the establishment and operation of a specialty retail outlet providing gems and beads targeted to the women's fashion market at outstanding prices directly to the consumer that includes books about making jewelry, wires, jewelry tools, hobby tools, a variety of gemstones, crystals, all kind of custom jewelry, local artist jewelry, other related crafts and jewelry items, and also offering customers annual memberships for discounted jewelry purchases and VIP discount cards to store owners and professional jewelry designers

Franchises can be established in 2 ways as a small market unit or as a large market unit. The total investment necessary to begin operations of a Gem and Bead Mall small market unit franchise is \$177,985 to \$330,950. This includes a \$32,500 franchise fee that must be paid to the franchisor or affiliate. The total investment necessary to begin operations of a Gem and Bead Mall large market unit franchise is \$290,235 to \$449,450. This includes a \$32,500 franchise fee that must be paid to the franchisor or affiliate.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale.
