

The franchise is a quick service restaurant featuring hamburgers, hot dogs, fries and drinks. You lease the location, furniture, fixtures and equipment from our affiliate. The total investment necessary to begin operation of a Wienerschnitzel will range from \$49,650 - \$135,000 This includes payments to us or our affiliate totaling \$12,250 - \$73,000, and if we provide development services for construction, 5% of construction costs

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English Read this disclosure document and all accompanying agreements carefully You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale Note, however, that no government agency has verified the information contained in this document

- YOU WILL NOT RECEIVE AN EXCLUSIVE TERRITORY YOU MAY FACE COMPETITION FROM OTHER FRANCHISEES, FROM OUTLETS THAT WE OWN, OR FROM OTHER CHANNELS OF DISTRIBUTION OR COMPETITIVE BRANDS WE CONTROL
