The franchise is offered for the rights to operate a Ginger Sushi Boutique franchised restaurant, a retail quick service restaurant selling a variety of sushi menu items and drinks, and other menu items using the trademark GINGER SUSHI BOUTIQUE™. In certain of our branding campaigns, we may reference the brand as Ginger Sushi + Poke Shop.

The total investment necessary to begin operation of a Ginger Sushi Boutique franchise in a food court location ranges between \$273,600 and \$340,000, including \$112,800 to \$121,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Ginger Sushi Boutique franchise at a street location ranges between \$265,560 and \$387,700, including \$120,700 to \$136,200 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a Ginger Sushi Boutique Institutional License franchise, depending upon whether you operate in a food court or street location, ranges between \$351,600 and \$979,700, including a total of \$14,500 to \$18,250 that must be paid to the franchisor or its affiliates.

The disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all agreements carefully. You must receive this disclosure document at least 14 days before you sign a binding agreement or make any payment in connection with the franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

2. THE FRANCHISE AGREEMENT STATES THAT ARIZONA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.

SPOUSE(S) OF FRANCHISE OWNERS AND DEVELOPERS MUST SIGN A PERSONAL GUARANTEE AND INDEMNITY MAKING SUCH SPOUSES JOINTLY AND SEVERALLY LIABLE FOR ALL OBLIGATIONS OF THE FRANCHISE, WHETHER OR NOT SUCH SPOUSES ARE INVOLVED IN THE OPERATION OF THE FRANCHISED BUSINESS. THIS REQUIREMENT PLACES THE PERSONAL AND MARITAL ASSETS OF THE FRANCHISE OWNERS AND SPOUSE(S) AT RISK IF YOUR FRANCHISE FAILS.
5. YOU MUST SIGN A SECURITY AGREEMENT GIVING US A FIRST PRIORITY INTEREST IN ALL PRESENT AND FUTURE ACCOUNTS, INVENTORY, EQUIPMENT, INTANGIBLES, PROCEEDS AND INTEREST IN THE FRANCHISE. THIS SECURITY INTEREST MAY IMPAIR YOUR ABILITY TO OBTAIN FINANCING FOR YOUR OPERATIONS.

6. PLEASE NOTE THAT APPROXIMATELY 95% OF FRANCHISOR'S ASSETS ARE INTANGIBLE OR INVESTMENTS IN SUBSIDIARIES. YOU MAY WANT TO TAKE THIS INTO CONSIDERATION WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE OPPORTUNITY.
7. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
