VPC Pizza Franchise, LLC offers franchises to operate restaurants known as Giordano's® Restaurants ("Giordano's® Restaurants"). Giordano's® Restaurants specialize in the sale of stuffed and thin-crust pizza, pasta, sandwiches, salads and other related food products prepared and sold in a manner and pursuant to specific recipes, formulas, techniques, methods of operation, procedures and standards.

The total investment necessary to begin operation of a Giordano's® Restaurant franchise is between \$645,000 and \$940,000 for a Limited-Service Restaurant and between \$1,401,000 and \$1,835,000 for a Full-Service Restaurant. This includes an Initial Franchise Fee of \$40,000 and payments for initial inventory totaling approximately \$3,000 to \$4,000 for a Limited-Service Restaurant and \$10,000 to \$20,000 for a Full-Service Restaurant that must be paid to Franchisor or affiliates.

This Disclosure Document summarizes certain provisions of your franchise agreement and Read this Disclosure Document and all accompanying other information in plain English. agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the Franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your Disclosure Document in another format that is more convenient to you.
