We offer franchises for the establishment and operation of a GNC retail store specializing in the sale of vitamins, minerals and other food supplements, natural cosmetics and other health management items.

We require you to sign a Franchise Agreement, which gives you the right to operate a single GNC retail store under the terms and conditions of the Franchise Agreement. The total investment necessary to begin operation of a new GNC franchise store ranges from \$167,650167.900 to \$281,350;294.500 and to convert a company-owned store to a franchise store ranges from \$104,150 to \$315,850; and for an independent health food/nutrition store to convert to a GNC franchise store ranges from \$79,900 to \$178,350.103.900 to \$1.109.000. This includes the following amounts that must be paid to us: \$154,500 to \$256,000252.500 for a new franchise store; and \$125,50090.500 to \$260,5001.007.000 to convert a company-owned store to a franchise store; and \$66,750 to \$143,000 to convert an independent health food/nutrition store to a GNC franchise store.

This disclosure document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least fourteen (14) calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

The terms of your contract will govern your franchise relationship. Don't rely on this disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Buying a franchise is a complex investment. The information in this disclosure document can help you make up your mind.
