The franchisee will operate a waterless car wash serving consumers and businesses at fixed locations and through mobile services. Some franchisees may also offer valet services in high-traffic areas. Each franchise will operate under the name "Go Green Auto Spa."

The total investment necessary to begin operation of a Go Green Auto Spa franchise is between \$47,000 and \$108,500. This includes \$17,500 to \$39,500 that must be paid to the franchisor or its affiliates as an Initial Franchise Fee plus sums ranging from \$1,000 to \$3,000 for initial inventory that may be paid to us.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
