_The franchises described in this disclosure document are for the establishment and operation of three different designs of family-oriented steakhouse and buffet style restaurants.

The total investment necessary to begin operation of a restaurant ranges from $\frac{1,971,5002,111,350}{10}$ to $\frac{4,302,0003,963,192}{10}$ for the least expensive restaurant design, to $\frac{3,447,700180}{10}$ to $\frac{6,756,5005,727,120}{10}$ for the most expensive restaurant design. This amount includes payments that range from 51,400 to $\frac{3,581,485413,675}{10}$ that must or may be paid to the franchisor or its affiliates.

We grant development rights to developers which enable them to open a specified number of restaurants within designated development areas under separate franchise agreements. The development fee is \$20,000 for each restaurant to be established, and is credited against the initial franchise fee for each restaurant. In addition to the development fee, the total investment necessary to acquire development rights ranges from \$100 to \$16,000, none of which is payable to the franchisor or its affiliates.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

You may wish to receive your disclosure document in another format that is more convenient for you. - 3. THE FRANCHISOR RETAINS THE RIGHT TO ESTABLISH FRANCHISED OR COMPANY-OWNED OPERATIONS WITHIN THE FRANCHISEE'S TERRITORY, SELLING SIMILAR PRODUCTS UNDER A DIFFERENT TRADE NAME OR TRADEMARK THAN THOSE DESCRIBED IN THIS DISCLOSURE DOCUMENT.
- 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.
