The Franchisee will operate a quick-serve restaurant under the name "Goldfingers", offering chicken tenders, Buffalo style chicken wings, wraps and related food and beverages.

The total investment necessary to begin operation of a Goldfingers franchise is between \$255,000 and \$655,000. This includes \$30,000 that must be paid to the franchisor and affiliate.
