The franchise offered is for the establishment and operation of a retail shop offering golf equipment and related accessories, club fittings, and the assembly and repair of golf equipment.

The total investment necessary to begin operation of a Golf Etc. franchise is \$325,000 to \$451,000. This includes \$179,500 that must be paid to the franchisor or affiliate, which includes the initial franchise fee of \$30,000. An up charge of \$12 per square foot will be added for shops having a floor space exceeding 4,000 square feet.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION/LITIGATION, IN GRANBURY HOOD COUNTY, TEXAS. OUT OF STATE ARBITRATION/LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE/LITIGATE WITH US IN TEXAS THAN IN YOUR HOME STATE.
- 2. THE FRANCHISE AGREEMENT STATES THAT TEXAS LAW GOVERNS THE AGREEMENT, AND TEXAS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS YOUR STATE'S LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. TOTAL ROYALTY FEES THAT YOU ARE TO PAY OVER THE 10-YEAR TERM OF THE FRANCHISE AGREEMENT LESS ROYALTY FEES YOU HAVE ALREADY PAID APPLIES IF YOU ARE NOTIFIED FOR CAUSE OF EARLY TERMINATION OF THIS FRANCHISE.
- 4. FRANCHISEE'S IMMEDIATE FAMILY MEMBERS ARE REQUIRED TO SIGN NON-DISCLOSURE AND NON-COMPETITION AGREEMENTS PLACING THEIR PERSONAL ASSETS AS RISK.
- 5. DURING THE PAST TWO YEARS, FORTY PERCENT OF OUR FRANCHISE OUTLETS HAVE CLOSED.
- 6. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
