Goodbye Graffiti™

We offer franchises for the operation of “Goodbye Graffiti” businesses specializing in graffiti removal and graffiti abatement (“Franchise Business” or “Business”). The Business includes (but is not limited to) products and techniques for graffiti removal and abatement as well as computer programs and codes, digital imaging systems, mapping systems, training, vehicle and equipment designs, branding and specifications and warehousing methods, as well as procedures for conducting advertising and other marketing and providing training and ongoing support to franchisees.

The total investment necessary to begin operation of a Goodbye Graffiti franchise is \$139,375 to \$192,252. This includes \$7,000 that must be paid to the franchisor or its affiliate. The Initial Franchise Fee is \$45,000 (\$33,750 for honorably discharged veterans of the U.S. Armed Forces and their spouses), plus \$7,000 for initial materials (“Startup Package”).

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive the disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

The terms of your contract will govern your franchise relationship. Don’t rely on the disclosure document alone to understand your contract. Read all of your contract carefully. Show your contract and this disclosure document to an advisor, like a lawyer or an accountant.

Please consider the following RISK FACTORS before you buy this franchise:

1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN WASHINGTON. OUT-OF-STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST MORE TO ARBITRATE WITH US IN WASHINGTON THAN IN YOUR OWN STATE.
2. THE FRANCHISE AGREEMENT STATES THAT STATE LAW WHERE THE FRANCHISE AGREEMENT IS SIGNED IS THE GOVERNING LAW, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS OTHER STATES. YOU MAY WANT TO COMPARE THESE LAWS.
3. GOODBYE GRAFFITI USA, INC. WAS FORMED ON JANUARY 1, 2017, IN WASHINGTON. WE HAVE A BRIEF HISTORY OF OPERATIONS. YOU MAY WANT TO CONSIDER THIS WHEN MAKING A DECISION TO PURCHASE THIS FRANCHISE.
4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We may use the services of one or more FRANCHISE BROKERS or referral sources to assist us in selling our franchise but we are not currently doing so. A franchise broker or referral source represents us, not you. We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
