Franchisee will operate a GOODCENTS® RESTAURANT ("Restaurant"), selling sandwiches, pasta and related food products and services at competitive pricing.

The total investment necessary to begin operation of a GOODCENTS RESTAURANT franchised business is from \$155,150 to \$276,100. For a new franchisee, this includes \$21,500 to \$22,000 which must be paid to the Franchisor and its affiliate; for an existing franchisee who buys a second or additional franchise, this includes \$11,500 to \$12,000, which must be paid to the Franchisor and its affiliate; for an existing franchisee who purchases the assets of an existing Restaurant, this includes \$11,500 to \$12,000 which must be paid to the Franchisor and its affiliate; if you are a franchisee and have been an employee of the Franchisor, or have been an employee of a GOODCENTS franchisee, for a minimum of 10 years, this includes \$11,500 to \$12,000 which must be paid to the Franchisor and its affiliate.

The total investment necessary to begin operation of a leasehold free-standing, with drive through, GOODCENTS RESTAURANT franchised business is from \$234,700 to \$382,800. This includes \$22,200 to \$23,000 that must be paid to the Franchisor and its affiliates.

The total investment necessary to begin operation as a developer under a Multi-Unit Agreement is \$30,000 to \$45,000, which includes an initial multi-unit franchise fee paid to Franchisor of \$20,000 for the first Restaurant to be developed and \$5,000 for each subsequent Restaurant to be developed according to the Multi-Unit Agreement.

The disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to the franchisor or an affiliate in connection with the proposed sale. **Note, however, that no government agency has verified the information contained in this document.**
