The goPerformance Franchisee will operate an upscale personalized fitness and performance training club under the Marks.

The total investment necessary to begin operation of a goPerformance Club (Studio Club size) is from \$119,550 to 348,750. This includes the \$20,000 to \$45,000 that must be paid to the franchisor or its affiliates. The total investment necessary to begin operation of a goPerformance Club (Standard Club size) is from \$215,550 to 551,250. This includes the \$22,500 to \$47,500 that must be paid to the franchisor or its affiliates. If you enter into a Development Agreement for multiple goPerformance Clubs, the initial development fee is \$5,000 for each goPerformance Club developed, which is applied against the Initial Franchise Fee payable for each goPerformance Club.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
