Grease Monkey Franchising, LLC is offering franchises for the operation of businesses that provide automotive lubrication and other approved automotive maintenance and repair services and for the operation of a car wash facility, either in conjunction with an automotive lubrication center or stand-alone.

The total estimated investment necessary to begin operation of one three-bay Grease Monkey center franchise is \$193,300 to \$347,000. This includes between approximately \$58,000 to \$66,000 that must be paid to the franchisor or affiliates.

A prospective franchise converting an operating automotive lubrication, maintenance and repair center which it already owns to a GREASE MONKEY Center pays a conversion fee of \$20,000 in lieu of the initial franchise fee, but may receive credits based on its prior year sales and length of operation which are applied against the conversion fee.

In addition, we offer the right to develop multiple centers in a designated geographic area under our Exclusive Territory Development Agreement. When an Exclusive Territory Development Agreement is signed, in addition to the \$30,000 initial franchise fee for the first Center you pay a development fee of \$9,000 for each additional Center to be developed.

The estimated initial investment necessary to begin operation of a one-bay Automatic Car Wash franchise ranges from \$172,650 to \$362,850. This includes \$5,000 that must be paid to the franchisor. The estimated initial investment necessary to begin operation of a one-bay Express Tunnel Car Wash franchise ranges from \$446,350 to \$817,135. This includes \$25,000 that must be paid to the franchisor. The estimated initial investment necessary to begin operation of various configurations of Self-Serve and Automatic Car Wash franchises are as follows: \$237,420 to \$377,410 for a two-bay Self-Serve and a one-bay Automatic Car Wash, \$253,240 to \$420,950 for a three-bay Self-Serve and a one-bay Automatic Car Wash, \$279,910 to \$458,330 for a four-bay Self-Serve and a one-bay Automatic Car Wash, \$296,550 to \$509,490 for a five-bay Self-Serve and a one-bay Automatic Car Wash, \$296,560 for a three-bay Self-Serve and a two-bay Automatic Car Wash and \$297,460 to \$440,330 for a two-bay Automatic Car Wash. These include between \$10,000 and \$25,000 that must be paid to the franchisor. See Items 5 and 7.



In addition, we offer the right to develop multiple facilities in a designated geographic area under our MS Exclusive Territory Development Agreement. When a MS Exclusive Territory Development Agreement is signed, in addition to the \$5,000 to \$25,000 initial franchise fee for the first Facility, you pay a development fee of the greater of \$3,000 for each additional Facility to be developed or \$18,000.

This Disclosure Document summarizes certain provisions of your franchise agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
