Grease Monkey Franchising, LLC is offering franchises for the operation of businesses that provide automotive lubrication and other approved automotive maintenance and repair services.

The total estimated investment necessary to begin operation of one three-bay GREASE MONKEY Center franchise is \$164,195 to \$319,850. This includes between approximately \$43,000 to \$66,000 that must be paid to the franchisor or affiliates. The high range of these estimated investment amounts includes the \$30,000 standard initial franchise fee for one GREASE MONKEY Center.

A prospective franchisee converting an operating automotive lubrication, maintenance and repair center to a GREASE MONKEY Center pays a conversion fee of \$20,000 in lieu of the initial franchise fee and is entitled to participate in our Conversion Franchise Royalty Rebate Program.

In addition, we offer the right to develop three or more Centers in a designated geographic area under our Territory Development Agreement. When a Territory Development Agreement is signed, in addition to the \$30,000 initial franchise fee for the first Center, you pay an initial franchise fee of \$18,000 for second Center to be developed and a \$9,000 initial franchise fee for each additional Center to be developed.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

OUT OF STATE ARBITRATION AND, IF APPLICABLE, LITIGATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN GREENWOOD VILLAGE, COLORADO AND, IF APPLICABLE, LITIGATE WITH US IN COLORADO THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT AND TERRITORY DEVELOPMENT AGREEMENT STATE THAT COLORADO LAW GOVERNS THE AGREEMENTS, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTION AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. SPOUSES OF FRANCHISE OWNERS MAY BE REQUESTED TO EXECUTE A PERSONAL GUARANTY PLACING THEIR PERSONAL ASSETS AT RISK.
