Grease Monkey businesses provide oil changes and preventive maintenance services for cars and trucks to the general public (“Grease Monkey Business(es)”). Grease Monkey franchisees may also operate a Monkey Shine car wash facility (“Monkey Shine Facility” or “Facility”) which provide car wash services to the general public.

The estimated total investment necessary to begin operation of a Grease Monkey franchise ranges from \$164,195 to \$335,850, including approximately \$30,000 to \$66,000 which must be paid to the franchisor or its affiliates. Grease Monkey area developers acquire the right to develop multiple Grease Monkey Businesses in a designated development area. The total investment necessary to begin operation of a Grease Monkey area developer business will depend on the number of Grease Monkey Businesses to be opened.

The estimated total investment necessary to begin operation of a Monkey Shine Facility franchise ranges from \$151,650 to \$761,135, including \$0 which must be paid to the franchisor or its affiliates. This is in addition to the costs to open a Grease Monkey Business.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**

IT MAY ALSO COST YOU MORE TO ARBITRATE/LITIGATE WITH US IN GREENWOOD VILLAGE, COLORADO AND, IF APPLICABLE, LITIGATE WITH US IN COLORADO THAN IN YOUR OWN STATE.
