The franchise is whole-wheat neighborhood bread companies.

The total investment necessary to begin operation of a Great Harvest Bread Company franchise is \$113,470 to \$642,004. This includes \$38,000 for a first-time location, and \$8,000 or \$18,000 for an additional location, that must be paid to the franchisor or affiliate. (You must pay us an additional \$3,000 for area development rights.)

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no governmental agency has verified the information contained in this document.**
