We, the Franchisor, are a California limited liability company known as Great Khan B, LLC ("GKMB") Great Khan restaurants of the type to be operated by you, the Franchisee, have been in business since 1997

GKMB is in the business of franchising the Great Khan Mongolian Grill Restaurants that are individually laid out, designed and constructed under GKMB's prior written approval Great Khan Mongolian Grill Restaurants will be located in shopping malls in either in-line or "foodcourt" settings, strip shopping centers, downtown locations or free-standing restaurants Franchisees typically operate one location but are able to operate several locations depending on their performance and ability as determined by GKMB Franchisees operate using the Franchisor's proprietary recipes, formulas, techniques, trade dress, trademarks and logos

The total investment necessary to begin operation of a franchise location ranges from \$154,000 00 to \$626,000 00 This includes up to \$60,000 00 that must be paid to the Franchisor or affiliate
