The franchised business is to operate a specialty salad restaurant business under the trade name "Green District"

The total investment necessary to begin operation of a Green District franchise is \$156,200 to \$297,000 This includes \$30,000 that must be paid to the franchisor or affiliate. The total investment necessary to begin operation under a three- to five-unit Multi-Unit Development Agreement is \$448,600 to \$1,445,000. This includes \$70,000 to \$110,000 that must be paid to us. There is no minimum number of Green District units that you are required to develop under the Multi-Unit Development Agreement.
