The franchise offered is for the establishment and operation of a business which primarily matches carefully screened, credentialed individuals to clients seeking "Companion-Sitters" or "Caregivers" to provide personal care, homemaking, companion care, incidental transportation, and other ancillary, supportive services to older adults, and ill or disabled persons who need extra assistance with activities of daily living.

The total investment necessary to begin operation of a Franchise ranges from \$124,225 to \$158,100. This includes a total of \$63,750 that must be paid to Griswold International, LLC for an initial territory size the greater of 250,000 people or 25,000 senior citizens and for the "Opening Purchases" described in Item 5 below. The initial territory may be expanded for an additional cost of \$0.10 per person up to a total population of 300,000 people, for an additional cost of up to \$5,000.

This Disclosure Document summarizes certain provisions of your Franchise Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.
