We grant you the right to operate a GROWING ROOM® Child Development Center Franchise (“Development Center”). Your Development Center will offer personalized, quality day care, education and development services for children between the ages of six weeks through twelve years.

The total estimated initial investment for this program is ~~\$889,000~~ ~~876,610~~ to ~~\$954,500~~ ~~941,375~~. This includes \$55,000 that must be paid to Franchisor or its affiliates.

If you sign an Area Development Agreement for the right to develop more than one Development Center you will pay us an Area Development Fee equal to \$27,500 multiplied by the number of Development Centers you agree to develop. The Area Development Fee is credited against the Initial Franchise Fee for each Development Center you open.

This Disclosure Document summarizes certain provisions of your Franchise Agreement, Area Development Agreement and other information in plain English. Read this Disclosure Document and all accompanying agreements carefully. You must receive this Disclosure Document at least 14 calendar days before you sign a binding agreement with, or make any payment to, us or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**
