The total investment necessary to begin operation of a Growler USA Microbrew Pub franchise ranges from \$396 363 to \$591 310 This includes \$35 000 to \$45 000 that must be paid to the franchisor. This does not include the cost to obtain a beer and wine or restaurant license
