The franchise offered in this disclosure document is for the rights to own and/or operate a GuestHouse International hotel.

The total investment necessary to begin operation of a 70 room GuestHouse International hotel franchise with a minimal food and beverage offering is estimated to range between \$3,442,000 to \$6,023,500 for new development and \$302,000 to \$1,273,500 for conversion hotels including the product improvement plan fee of \$5,000 that must be paid to the franchisor. These amounts also include an application fee of \$40,000 paid to the franchisor. These amounts do not include the cost of purchasing or leasing land or any real estate taxes.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar-days before you sign a binding agreement with, or make any payment to, the franchisor or an affiliate in connection with the proposed franchise sale. Note, however, that no governmental agency has verified the information contained in this document.

- 2. THE FRANCHISE AGREEMENT STATES THAT WASHINGTON LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
