The franchises described in this disclosure document are for the operation of a business offering residential building construction, remodeling and repair; construction consultation; and other construction services under the name $\mathbf{GuyCo}^{\mathsf{TM}}$.

The total investment necessary to begin operation of a GuyCo[™] franchise is between \$63,500 and \$111,300. This includes a \$39,500 franchise fee that must be paid to the franchisor.

This disclosure document summarizes certain provisions of your franchise agreement and other information in plain English. Read this disclosure document and all accompanying agreements carefully. You must receive this disclosure document at least 14 calendar days before you sign a binding agreement with, or make a payment to the franchisor or an affiliate in connection with the proposed franchise sale. **Note, however, that no government agency has verified the information contained in this document.**

- 1. THE FRANCHISE AGREEMENT REQUIRES YOU TO RESOLVE DISPUTES WITH US BY ARBITRATION ONLY IN HENDRICKS COUNTY, INDIANA. OUT OF STATE ARBITRATION MAY FORCE YOU TO ACCEPT A LESS FAVORABLE SETTLEMENT FOR DISPUTES. IT MAY ALSO COST YOU MORE TO ARBITRATE WITH US IN INDIANA THAN IN YOUR OWN STATE.
- 2. THE FRANCHISE AGREEMENT REQUIRES THAT INDIANA LAW GOVERNS THE AGREEMENT, AND THIS LAW MAY NOT PROVIDE THE SAME PROTECTIONS AND BENEFITS AS LOCAL LAW. YOU MAY WANT TO COMPARE THESE LAWS.
- 3. ARBITRATION WILL NOT BE USED FOR ANY DISPUTE WHICH INVOLVES A FRANCHISEE'S CONTINUED USAGE OF ANY OF THE MARKS OR ANY ISSUE INVOLVING INJUNCTIVE RELIEF AGAINST FRANCHISEE, ALL OF THESE ISSUES WILL BE SUBMITTED INITIALLY TO A COURT IN HENDRICKS COUNTY, INDIANA. THE PARTIES CONSENT TO PERSONAL JURISDICTION IN INDIANA OVER ANY SUCH ISSUES NOT SUBJECT TO ARBITRATION.
 - 4. THERE MAY BE OTHER RISKS CONCERNING THIS FRANCHISE.

We pay this person a fee for selling our franchise or referring you to us. You should be sure to do your own investigation of the franchise.
